Celebrate our activism in 2022 – National to Local (Judy)

- Critical negotiations between key lawmakers would not have taken place if we hadn't been doing our work in Congress all these years and in particular over the last 18 months. The Inflation Reduction Act will have an enormous, positive impact on the US approach to climate change.
- Locally we've been involved in important climate action steps by both the Moscow and Pullman city governments.
- Our 2022 actions by the numbers:
 - Media: Op-Eds > 10. Articles > 5. LTEs > 28, Radio appearance 1,
 - Constituent contacts with members of Congress > 117,
 - Meetings with members of Congress > 6 (including 1 town hall)
 - Chapter Development > 73 events/actions
 - Grasstops outreach > 21 events/actions
 - Grassroots outreach > 36 events/actions, including 2 parades

- **Feedback from our local attendees**
 - Several members described sessions they attended. Talk given by woman in Madison, WI about local efforts with electrification and other climate action was very good as was the Electrify America talk. There was a link to what you can do and what money you'll get back (e.g. tax rebates for buying EVs) because of the IRA. Also discussed was the importance of the permitting process related to expansion of transmission lines for electrification efforts. We must work on legislators to address the currently very slow interstate permitting process. Building out transmission lines is critical to 40% emissions reduction by 2030.
 - A quote from one of Pete Haug's op-eds was read at the virtual conference and our Palouse chapter was mentioned!

COMMUNICATION SKILLS EXERCISE - Practice leading with who we are by telling your story

Citizens' Climate Lobby offers every person who is worried about climate change the opportunity to make an impact beyond their personal lifestyle choices. Our education and training turns ordinary citizens into highly effective volunteer lobbyists, organizers and communicators who get meaningful climate legislation passed. An especially effective way to introduce other people to CCL is to start with your own story and the part that CCL played in making you an effective advocate for climate solutions. Let's practice.

Three moments in time - your story and the role CCL played in your journey

Describe in your own words the transition from your pre-CCL self to your current self as an effective climate solution advocate. Use the three questions below to get started telling your story.

1. What worried you about climate change before you discovered CCL? *E.g., "I didn't feel like I could make a difference," or, "I worried often about the impact of climate change on my children and grandchildren."*
2. How has joining the CCL community encouraged you to do more? *E.g., "I found an organization that helped me discover my voice," or, "I discovered that many people care about our climate as much as I do and that gives me hope, energy and a clear direction."*
3. How do you see your CCL work contributing to an effective climate movement? *E.g., "I've already seen CCL help pass some major bipartisan bills in Congress," or, "I've been able to establish a relationship*

with my member of Congress and talk to them about climate change, something I never thought was possible before joining CCL.”
