### Film Series

Film screening and discussion series (Clare and Annette). This is evolving into a possible series of positive, action-oriented films next year, possibly at the Kenworthy and/or the universities. The Sierra Club might participate. Suggestions: get UI faculty at the Confluence Project involved; pursue funding through the Latah County Community Fdn or the Moscow Giving Circle. If students make the request, there could be funding through the student associations at UI and/or WSU.

## Carbon Price and Cash-back Team report (Simon)

- We are already paying a carbon tax due to government spending on climate impacts and projected impacts, so we should change the narrative: get away from the current hidden "carbon tax" and use "fee and cashback").
- The border adjustments other countries are imposing on carbon-intense U.S. products (aluminum, steel, fertilizer and concrete) means legislators want to find a solution. This may or may not include a carbon fee.
- Some Canadian provinces have just started issuing dividends from their carbon tax. We should broadcast this information.
