Bill McKibben: Pro-Activist – Mary

Bill McKibben of 350.org was CCL's monthly guest speaker (https://citizensclimatelobby.org/monthly-speakers/). Major points included:

- Renewable energy has increased by 90% recently. Now the problem is deploying fast enough. We
 have to talk to our friends who are environmentalists but have NIMBY (Not In My Back Yard) concerns
 re solar/wind. We need immediate permitting reform for energy projects must pass climate test,
 fairness test for impacted communities, and encourage community projects
- Protecting farmland against use for solar/wind is important to some, but lots of farmland used for corn
 production which goes to ethanol for fuel (40%). Iowa, a very productive agricultural state, has more
 wind turbines than many states.
- His new organization, Third Act, is an organization for 60+ who tend to have more political power and
 more money. Its first goal is to go after big banks who fund fossil fuels, and then to reform state public
 utility commissions.
- El Niño cycle will be bad this year and worse next. We will exceed 1.5 deg C.
- With the smoke cloud hanging over the East, finally people in power are experiencing what a lot of the rest of people experience. 3 mil people will die this year because of air pollution.

CCL Conference Reports - Daniel, Judy

- Had > 1000 CCLers, 430 lobby meetings.
- Daniel met with 3 Republicans, 1 Democrat although the last got cut short.
- Saw more bipartisan support of permitting reform than expected.
- Supporting Ask included Increased Technical Service Providers (TSP) Access Act. TSPs are
 conservation experts on land management for mitigating climate change. They work through the
 Natural Resources Conservation Service to assist a famer or rancher or forester to help make land
 resilient. These professionals are in short supply. They must get certified through the USDA which is a
 bottleneck. The 2018 farm bill allowed the USDA to establish non-government certifying offices to meet
 certain requirements, but USDA didn't follow up; the Access Act is telling the USDA to do it.

Carbon Price and Dividend Team Report - Margaret and Simon

- Carbon Border Adjustment Mechanisms (CBAM) panelists for this CCL Conference session included Ross Astoria, U Wisconsin Parkside; Catrina Rorke, Climate Leadership Council; Shuting Pomerleau, Georgetown U.
- The Carbon Fee and Dividend legislation supported by CCL included 1, a Carbon fee, 2, a Dividend and 3, a Border Adjustment Mechanism to even the playing field for American companies. A CBAM can be a stand-alone version of #3. US already cleaner manufacturing than many countries, and this could be rewarded by charging a fee on imports from more carbon-intensive countries.
- EU has a new CBAM policy. They will implement reporting on imports of certain things like steel, etc. this year and will start charging a fee in 2026.
- The new PROVE IT Act will provide data to report on this US advantage.
 - PIA is in Senate, not in the House yet.
 - o Carbon intensity study on products at manufacture (steel, aluminum, etc. see bottom of page)
 - o Agencies: DOE, DOC, EPA, State
 - Have 2 years to do it
 - DOE must update every 5 years
- Must satisfy WTO regulations for equal treatment (some discussion included how feasible the CBAM is
 in absence of domestic carbon fee. However, different countries can be treated equally if based on
 carbon intensity thus data is essential!).
- Difference between border adjustment and tariffs tariffs are more unilateral.
