Practice explaining the benefits of the BIG WIRES Act

To reinforce CCL's November lobbying primary ask — the BIG WIRES Act — we're asking everyone to call their Senators and Rep this month to urge them to cosponsor the bill. When you invite friends, family and table visitors to call, it's best to start by describing the benefits of the BIG WIRES Act. Let's practice.

Benefits - BIG WIRES Act

<u>Improve electrical grid reliability</u>. Establishing minimum-transfer requirements would mean more power can flow between regions, which is key to electrical grid resilience and reduced blackout risks.

<u>Reduce energy costs</u>. Upgraded transfer capabilities would dramatically lower energy costs for American families, both by allowing regions where power prices are cheap to sell to regions where it is more expensive and by allowing all regions to connect new, low-cost resources to the grid.

<u>Connect more clean energy</u>. Increased transmission capacity and pathways between regions will increase the ability of regions to connect clean energy to the grid.

<u>Reduce emissions</u>. Transmission is an important part of permitting reform, and without sufficient permitting reform, 80% of the emission reductions in the Inflation Reduction Act will not be realized.
