Reports

- ***Not the End of the World: How We Can Be the First Generation to Build a Sustainable Planet***, Hannah Ritchie – Review by Pete. Slide 1:Reduction in ozone-depleting gases has been more than 99% - the point is we can do things if we have the collective will. Slide 2 shows correlations between diets and greenhouse gas emissions. Six main points included in Ritchie's book: 1) We face big environmental challenges. Probably not as bad as nuclear war or massive pandemic. 2) Doesn't mean we shouldn't work on them. 3) We have to hold multiple thoughts at the same time – things getting better doesn't mean the job is done. For example, since 1990 the number of children dying every year has more than halved but there are still 5 million dying every year. No contradiction there. The world is much better, still awful. 4) None of it (dire environmental consequences) is inevitable but is possible. 5) We cannot afford to be complacent. We need a broad overview. The move toward renewable energy is going fast, but the journey to a sustainable world will have blips. Things may stall or regress. 6) You're not alone. Many people are working for a better future.
 - This book was published this past January. Media attention: reviewed by the NYT, Guardian, BBC, NPR. Would be suitable for high school.After Pete's review, several were interested in suggesting the book for WSU and UI common reading books. Kent and Leonard will follow up.
- **"The Surprisingly Simple Way to Convince People to Go Green"**, Michael Coren, Washington Post, 12-5-23 – Judy. Providing data or facts ranked last, persuading an average of 3.5 percent of people to change their behavior compared to a control group. Setting personal goals and appeals to act more sustainably fared better, but were still middling performers. Financial incentives such as subsidies or

savings performed relatively well, persuading about 12 percent. Leading the pack were what scientists called “social comparisons” — people’s ability to observe the behavior of others and compare it with their own. This persuaded more than 14 percent of people to change their behavior in experiments from around the world. Those comparisons could be as passive as observing a neighbor’s solar panels or receiving notices about household energy use.

- **Reclaiming Our Democracy: Transformational Advocacy**, CCL Guest Speaker Sam Daley-Harris – Judy relayed Daley-Harris’ recommendation for “transforming” volunteers into powerful democratic actors by training and supporting them/us to act, and by making big asks of ourselves and other volunteers.

- **I-2117 in WA** – If I-2117 passed, it would be repeal WA’s Climate Commitment Act that established a carbon emissions cap and trade system to decrease emissions. Passage of I-2117 would be a disaster not only for our climate agenda in Washington State but also nationally as it would send a strong message that significant action on climate can’t be sustained. Actions we can organize for now and carry out through the year:

COMMUNICATION SKILLS EXERCISE: Farm Bill talking points

Trees pull the equivalent of 12% of America’s carbon pollution out of the air each year and with climate-smart protection, expansion and management, our forests could pull up to 22% of pollution by 2030. The Inflation Reduction Act in 2022 allocated \$20B for climate-smart forestry in the Farm Bill. The Farm Bill is up for renegotiation and renewal this year, so we want Congress to protect this funding. So that you can help advocate for this, let’s practice saying CCL’s **Farm Bill talking points**:

1. The Farm Bill is our nation's largest investment in agricultural producers. It contains significant federal policy for conserving our nation's soil, land, and water resources.
2. Current Farm Bill conservation, forestry, and resilience programs are only meeting a fraction of the needs and demands from farmers, ranchers, and forest owners who are on the front lines of climate change.
3. Back in 2022, as part of the Inflation Reduction Act, Congress allocated \$20 billion to voluntary, incentive-based conservation and climate-smart forestry and farming programs.
4. Congress must protect and build upon that investment as they renegotiate the Farm Bill this year.
5. You can help by writing to urge Congress to protect the \$20B of climate-smart agroforestry funding in the Farm Bill. Use our [Take Action tool](https://cclusa.org/protect-forests) (cclusa.org/protect-forests) to write.
