I-2117 would recall that. The CCA did raise gas prices ~ 30 cents/gal although other causes contributed to more rise, but everyone blamed the CCA, which is already bringing emissions down and funds other projects that bring emissions down, supports low income communities, bus conversions to electric, building of a greener grid, more walkways to school, rebates for lower income people to install heat pumps, air quality monitoring, pollution reduction projects, energy vouchers, new urban tree canopy, and public transit free or under 18s.
  - Passage of this campaign could negatively affect others initiatives across the country

# Communication Skills Exercise (see toward the end of the Agenda)

### Report on CCL-P finances: Steve Flint

We don't fundraise in any organized way, although we have donors. Not a lot of expenses: couple of hundred/year for Moscow meeting room here, Moscow Chamber of Commerce \$140 (someone in Pullman pays Chamber dues there). Other spending includes web site, tabling and printing expenses. Still have about \$1000 that can be used to help send someone to the national conference or get a billboard or for other use. \$750/ month cost for billboard, need lead time. \$69/yr for web site. We don't have a good mechanism for local fundraising. Since CCL is a lobby group, donations to CCL are not tax deductible. However, one can donate to national CCL's tax deductible arm, Citizens Climate Education, get a tax deduction.

## **Ongoing Palouse CCL Initiatives and Actions**

Lobbying Congress--

Mac (Senator Crapo, ID) and Judy (Congressman Cathy McMorris Rodgers, WA)

Judy: One of the things we are convinced of is that having <u>national</u> policy would be most effective, which is why we lobby congress. Especially important is the carbon fee and dividend which would impose a rising fee on emissions and the money would be sent back to households. We also strongly back energy permitting reform like faster transmission line permitting and building. A solar farm proposed here was pulled because of lack of transmission capacity. Now we support the BIG WIRES Act which would improve transmission capacity and resilience. When we go to Congress, we talk about what would be most likely to be passed (like BIG WIRES, and things like environmental components of the Farm Bill, and the PROVE IT act which would mandate data collection for comparison to other countries' carbon emissions). Usually we just meet with staff, sometimes also the MOC, and we try to connect with MOC values. Judy liaison for McMorris Rodgers, Mac is liaison for Crapo. Right now over 10 people from WA and four people from ID are going to lobby in DC in June. CCL's is the largest single day lobby effort in DC. Lobby training zooms from national will be available.

  - Modeling of climate policy effects pre-IRA are outdated
  - Brookings Institute's Hamilton Project published a post-IRA model of the effects of 7 policy scenarios in Feb 2024 ("Climate tax policy reform options in 2024")
  - 3 years ago, the Build Back Better Act included
    - 1. Clean electricity standard
    - 2. Carbon price
    - 3. Clean tech tax credits and rebates
      - Only # 3 passed in the IRA
  - Scenarios considered by Hamilton/Brookings:
    - 1. IRA + EPA (EPA= tailpipe standards and power plant rules under Clean Air Act to be finalized in 2024)
      - 6 years behind the Paris target
    - 2. IRA EPA
      - 10 years behind Paris targets
    - 3. No IRA or EPA
      - Just bad
    - 4. IRA expansion + EPA
      - Not much difference
    - 5. Clean electricity standard + IRA + EPA
      - Not much difference
    - 6. Carbon price + partial repeal of IRA
      - 2 years behind Paris target
    - 7. Carbon price + IRA + EPA
      - Best scenario- 47% cuts by 2030, with the EICDA would reach 50%
- Building Electrification and Efficiency Mac Cantrell and Mary DuPree (leads)

Judy: Update on new FERC electrical grid regulations

Require transmission providers to plan 20 years into future.

Federal energy regulatory commission will step in if process too slow

Contentious vote: "red" states don't want to pay for "blue" state clean energy BIG WIRES act is still necessary.

### • **Healthy Forests** — Trish Hartzell (lead)

- CCL sponsored planting at the WSU fruit farm. Many trees were planted but they have a rodent problem (ground rodents girdling the base of young trees and they die). They will try bringing in raptors, or castor oil balls.
- o Arbor day event planting at the elementary school near the University of Idaho.
- o We will continue watering plants at the Pullman center.
- There is a plot of land in northeast Moscow where we could start planting now.
- We could partner with PCEI.
- Latah conservation district

- **Pullman City** Azdren Coma (not here) Marilyn: The Environmental Resilience Commission in Pullman is working on a climate action plan. They are preparing a survey that is a follow-up to the last survey.
- Moscow City Mary DuPree

Mary: Report on Moscow Issues. A recent questionnaire was sent out randomly and each commission was allowed to include questions. People expressed concern about climate change, especially air quality, transportation costs, reduced precipitation and snow pack, more frequent high heat days. Actions they would support included promoting local food sources, utility rebates, alternatives for pest control, charging stations, and electrification of buildings. The city's climate action working group is working on an action plan and talking about having a building efficiency and electrification workshop.
