Navigating Advocacy in a Changing Political Landscape

COMMUNICATION SKILLS EXERCISE

We know that people learn best by saying the words aloud. When tabling you'll approach and speak with folks representing a wide swath of the public. So, for this exercise, we've provided an example conversation.



Instructions:

1. With a partner, **take turns reading the sample conversation below.** (If you use Zoom breakout rooms, do the same exercise in small groups, three to four people per room, for six minutes.)
2. Afterward, **share the points you remember** from the exercise.

Sample conversation:

Friend: Hey, so you're still doing that climate thing? How are you guys even working with this Congress these days? It seems impossible.

CCL Supporter: Yeah, still very involved! It's definitely different with Republicans holding narrow majorities in both the House and the Senate and President Trump back in the White House.

Friend: Right, I can imagine that changes things. What's CCL's strategy now?

CCL Supporter: Well, CCL's core strategy is designed to work across multiple Congresses and political shifts. We're nonpartisan and constituent-driven, which is actually well-suited for the current Senate, where most legislation still requires bipartisan support because they're seven votes short of overcoming a filibuster.

Friend: Interesting. So what are your priorities right now? What are you actually asking for?

CCL Supporter: Our main focus initially was defending the clean energy provisions in the IRA. This is actually the first time CCL has primarily played defense instead of offense (trying to pass new bills). We're also supporting the Fix Our Forests Act and foreign pollution fees.

Friend: Defending? Are Republicans trying to get rid of the clean energy tax credits?

CCL Supporter: Republicans are on both sides of the tax credits debate right now. Our volunteers are engaging with offices by showing appreciation and respect. With Republicans, we often frame things around the economy, jobs, and global competition – that tends to be a good opener.
