Climate Activism 101 — Simon spoke about his presentations at Moscow High School to address climate anxiety. Activism: the anxiety antidote. For example, Exxon used to be a leader in climate research. Then they fired their scientists and tried to deny the bad news. We can take action to address climate disruption in lots of ways. A current paper in *Nature* discusses how to divide up liability, and now arguments have entered the legal arena. New sodium battery technology is promising because lithium is difficult to get. It is a heavy battery, not ideal for transport but charging speed and storage good for storing power from solar and wind. Other groups for these great presentations: possibly an SEL "university".

Also, Simon is meeting with Pete Chittenden, Pullman Chamber of Commerce Executive Director, about the proposed CCL Electrification and Efficiency Fair.

Planning meeting July 2, 4:30pm, 320 Adams, Moscow

We need City of Moscow participation. Leonard is meeting with CoM's Sustainable Environment Commission July 15 6 PM at city hall. We also want to talk to people involved with installing heat pumps. Oscar Guzman has an HVAC company in Lewiston that installs heat pumps but they have so much work already they're too busy to participate. We need to find more contractors. Marilyn talked to the City of Pullman Environmental Sustainability Commission. Kelly Cooper is a new member of that commission. She said she would take our request to the Pullman group. Kent and Bill Voxman met with Paul Kimmel of Avista. He is very enthusiastic and sees supporting it as consistent with Avista's goals. Avista is already doing energy fairs aimed at efficiency. Some specific thoughts: combining an exhibitor/fair approach with a lot of businesses, breakout presentations about home electrification, EVs, etc. He recommended other contacts. When to get him to planning meeting? Mary and Leonard had several contacts including Home Depot and Moscow Building Supply. Judy contacted the WSU Department of Design. They're doing research on behavior with respect to energy efficiency and are interested in participating.

## Communication Exercise – PERMITTING REFORM

Friend: What's this I hear about "permitting reform?" And does CCL support it?

**CCL Volunteer:** Great question! Yes, we do support permitting reform. Basically, permitting is the process big energy projects go through to get government approval before construction. It's like needing a building permit for your house, but way more complex. Right now, **more than 90% of projects waiting for permits are clean energy like solar, wind, battery storage**, but the process is so slow that they're stuck in line for years.

**Friend:** But isn't permitting important for safety and the environment?

**CCL Volunteer:** Absolutely. Permits are there to protect us, but the system is outdated. It takes over four years just to complete some environmental reviews, and over a decade to build a new transmission line. That's too slow if we want to meet our goals to reduce greenhouse gas emissions. The good news is, **smart reform can speed up good projects while still protecting communities and rejecting harmful ones faster.** 

**Friend:** How does this help with climate change?

**CCL Volunteer:** If we don't build clean energy faster, we can't cut emissions fast enough. Plus, it improves air quality and can save tens of thousands of lives, especially in frontline communities. And it creates jobs, especially in rural areas where clean energy is being built.

**Friend:** So it's not just red tape removal then, it's a jobs, health and climate strategy?

**CCL Volunteer:** Exactly. And CCL's pushing for reforms that **speed up clean energy, boost transmission,** and make sure communities get a say in what gets built.
