### Celebrating Successes – Judy

What we've done this year.

- 39 + calls to Members of Congress, 258 e-mails & letters to MOCs, 8 lobby meetings, 8 presentations, 24 + media publications, 10+ tabling, 5+ other: the Lentil Parade, Electric Transportation Fair, Pizza for the Planet, Moscow CAWG, Pullman Comprehensive Plan, Pullman Climate Action Plan, the Johnson parade.
- Recent publications: Moscow-Pullman Daily news: Fighting Climate Change, Mary 11/1-2/25; Leonard, Spokesman-Review 12/ 6-7, Mary, Spokesman-Review
- Nationally, CCL sent > 129,000 messages to congress and > 23,000 calls.
- Other successes include budget reconciliation improvements, and bipartisan permitting reform.

### Energy Efficiency and Electrification Fair, April 4, 2026 – Leonard, Mac, Mary, Margaret, Simon, Judy, Kent

- Planning meeting Jan 14, 3 pm, Mary's house at 320 N Adams, Moscow
- Leonard update:

- We have at least 7 significant sponsors. Avista, the City of Moscow, Inland Power, both Chambers of Commerce, Moscow Building Supply ad Groppe Electric.
- The venue is the Latah County Fairgrounds, and can fit 42 booths plus in the anteroom. There is an extra room where we can have panels and presentations.
- We can put it on different community calendars
- Will be free for attendees.
- The purpose is to show how you can save money on power while lowering emissions with HVAC, solar, windows, etc.
- We have been meeting monthly with Paul Kimmel who has been very helpful.
- We have divided up businesses to contact. We also could include banks because they do loans for remodeling. We are thinking about including Colfax, Lewiston, and Spokane
- If you have contacts with businesses, please let us know.
- We will have food trucks and the Avista electricity safety trailer. Also the Palouse Discovery Science Center will do an event for kids.

### **Fossil Free WSU Update – Bill**

We only had 3 meetings this fall and gave public comment at every Regents meeting. At the last meeting Kent Keller presented a striking graph showing the data on climate change. Fossil Free and WSU ESA will stage a demonstration in March or April and have asked CCL and other orgs to join in.

### **Washington Utilities and Transportation Commission Update – John**

Avista made a request for recovery of cost specific to their investment in Colstrip (a coal plant in Montana) over time. They are asking permission to charge customers to pay for previous investment in Colstrip in order to sweeten the deal for the Montana company that is buying it. This is technically legal but questionable. It might be a good idea to approach media for attention. The Montana Energy Information Center is a good source of information, as is the NW Energy Coalition. It is rare to focus on one energy source in this way.

- **Pullman City** –Marilyn Von Seggern, Stephan Flint. Marilyn is working on the Pullman Comprehensive Plan revision process. Steve reported that the Environmental Resilience Commission will recommend that the city be a sponsor of the EEE Fair. CCL will present our request for sponsorship to the city council January 27.
- **Whitman County Planning Commission on wind project code** -

Judy, Simon, Kent and many farmers were at the commission meeting. The new drafted code includes miles-wide setbacks around Kamiak Butte and other public lands. It also requires wind turbines to be set back from nonparticipating properties by six times the height of the tower. Setbacks would make it impossible for small farms to have turbines. If adopted, this code would be one of the most restrictive of anywhere in the US. ### **PART A — Sample Outreach Message**

Hi [Name], hope you're doing well! I'm reaching out because I'm volunteering with Citizens' Climate Lobby, and I'm helping with our year-end fundraising effort.

I wanted to see if you'd be open to a short 10-minute chat this week or next. I'd love to share what we're working on and ask whether you might consider joining me in supporting their work by making a year-end gift — totally no pressure either way.

### **PART B — Sample Conversation Once They've Opted In**

**You:** Hey, [Name]! Thanks for taking a few minutes to talk with me — I really appreciate it. How's everything going?

**Friend:** Good! Thanks for thinking of me. I'm excited to learn more about Citizens' Climate Lobby.

**You:** That means a lot — thank you. As I mentioned, I volunteer with Citizens' Climate Lobby, and this year has been a big one for us. Just last month, we held more than 300 virtual lobbying meetings with Congress to help move climate policy forward. *[If you participated in a lobby meeting, mention that.]* Even in a polarized political landscape, we're still making real progress with lawmakers — it keeps me hopeful and motivated.

**Friend:** That sounds great. That's so important.

**You:** I care about this work a lot, which is why I'm reaching out to a few people in my life about supporting it. CCL is funded mostly by individual donors, and year-end gifts help keep our grassroots lobbying and volunteer training going. Would you consider making a donation this year?

**Friend:** Maybe — what exactly do you use the money for?

**You:** We have a small national staff who use their policy expertise and timely insights from Capitol Hill to train volunteers, coordinate the asks for our lobby meetings, and help us respond quickly when Congress is taking action on climate. Funding keeps that engine running so volunteers like me can be effective.

**Friend:** That sounds great, I'd be happy to contribute.
